NOTICE

It was observed in the previous academic year (i.e., 2016-17) that some of the faculty members possessed multiple Registration numbers against their names. Added to this situation some faculty members have flouted the Affiliation regulations 2016 by their fraudulent presence in more than one College and ended up as fraudulent/blacklisted faculty using these multiple registration numbers. In this context, for the upcoming Affiliation process for A.Y.2017-18, all the faculty members registered with the JNTUH Faculty portal, if he/she has **more than one Registration number**, they are hereby instructed to submit the format given in the **ANNEXURE** (enclosed) on a Stamp paper worth Rs.100/- and submit the same to the University Registrar office (Inward section) **on or before 23-01-2016 5.00 P.M.** The Faculty members are hereby instructed to clearly mention the Registration number which should be **ACTIVE** throughout his/her association with JNTUH Faculty Portal and the Registration number(s) which need to be **DELETED** as given in the ANNEXURE. This will facilitate the Faculty member to possess only **ONE Registration number** against his/her name in the JNTUH Faculty Portal. No faculty member from now onwards shall have more than ONE Registration number and if this condition is violated, it will be treated serious and may attract punitive action as well.

Further, if the Faculty members possessing Multiple Registration numbers against their name and do not submit the ANNEXURE at the University within the due date/time, all his/her Registration numbers shall be DELETED in the Faculty portal and no further correspondence shall be entertained in this regard.

NOTE for New Registering Faculty Members: Each Faculty member shall have only ONE JNTUH Registration number against his/her name. Further, shall assure that he/she will take sole responsibility from any of kind of misuse of his/her Registration number.
